Biodegradable waste includes all organic waste materials from the garden and kitchen.



What is allowed

- Small amounts of rotten food products
- Food waste
- Egg shells
- Coffee and tea filters
- Leaves, lawn and plant cuttings
- Sawdust, hay and straw (non-contaminated)
- Weeds, potting soil and flowers
- Leftover food
- Bones
- Fruit rinds/leftovers
- Vegetable waste



What is not allowed

- Plastic packaging
- Plastic bags
- Porcelain
- Cat litter
- Ash
- Nappies
- Glass
- Scrap metal
- Residual waste
- Paper and cardboard
- Hazardous materials
- Electrical appliances

Packaging waste made of metal, composite materials, plastic as well as non-packaging of similar material should all be placed in the **recycling bin**.

Hazardous Materials



Electrical and electronic devices

Hazardous materials pose a serious danger to the air, earth and ground water, which is why it is important to dispose of these materials in the correct manner.

Harmful substances from private households can be disposed of using the **mobile hazardous waste unit** or dropped off at our **communal collection points** in AEZ Watenbüttel and at our Frankfurter Strasse premises during the respective opening times.

The **schedule for the mobile hazardous waste unit** can be found online at www.alba-bs.de.

Hazardous liquids are to be delivered in securely closed containers.

The German Electrical and Electronic Equipment Act (Elektronikgerätegesetz), which regulates the **free collection** of old electrical appliances has been in force since 2005.

Small and large electrical appliances can be disposed of **free of charge** at our **communal collection points** in AEZ Watenbüttel and at our Frankfurter Strasse premises during the respective opening hours.

Large electrical appliances can also be picked up by the bulk waste collection service for a fee of EUR 15.00. In order to do this, we require a written registration stating your name, the collection address and the number of objects to be collected.

Small electrical appliances can also be handed in to our mobile hazardous waste unit **free of charge** or disposed of at various locations in Braunschweig using the new **collection containers**.



The following harmful substances can be disposed of using the mobile hazardous waste unit

- Varnishes and oil paints
- Solvents, heating oil, diesel, acids, alkaline solutions
- Chemicals, household and drain cleaning products
- Wood and plant protection products
- Anti-corrosion agents
- Spray cans, foam insulation cans
- Batteries for cars and other appliances
- Car maintenance products
- Fluorescent tubes and energy-efficient light bulbs
- Disinfectants and adhesive agents
- Batteries



The following harmful substances **CANNOT** be disposed of using the mobile hazardous waste unit

- Gas bottles and asbestos waste
- Wall and ceiling paints are water soluble and should be dried out and disposed of in the residual waste container; the same applies to protective covers, brushes and pharmaceutical products.
